NOTICE IS HEREBY GIVEN that the Sacramento County Board of Supervisors will hold a public hearing pursuant to the Fair Maps Act and Elections Code Section 21507.1 at which the Board of Supervisors will receive a report on the redistricting process and permissible criteria to be considered to adjust electoral district boundaries and receive public input on communities of interest and potential district boundaries. HEARING DATE: TUESDAY, DECEMBER 7, 2021 at 2:00 PM HEARING LOCATION: Sacramento County Administration Building Board of Supervisor Chambers 700 H Street, Room 1450 Sacramento, CA 95814 PUBLIC COMMENT PROCEDURES: In compliance with directives of the County, State and Centers for Disease Control and Prevention (CDC), the meeting will be live stream and open to public attendance pursuant to guidelines related to social distancing and minimizing person-to-person contact. IN-PERSON PUBLIC COMMENT: Members of the public may address the Board in-person to make a public comment. A facemask and social distancing are required while inside the County Administration Building and Board Chambers. Seating is limited and available on a first-come, first-served basis. Members of the public addressing the Board will be required to complete and submit a speaker request form to Clerk staff. The Chairperson will invite each individual to the podium to make a verbal comment during the public comment period for each agenda item or off-agenda matter.
